# Pocket AI, Inc. TERMS OF SERVICE

Last Updated: May 1, 2025

These Terms of Service constitute a legally binding agreement between you (including individual affiliated with you that has been authorized to use the Services on your behalf) and Pocket AI, Inc. (together with its affiliates, "**Tredit IQ**", "we," "our" or "us") governing your use of our products, services, and website (the "Site" and collectively with the foregoing, the "**Services**").

YOU ACKNOWLEDGE AND AGREE THAT, BY CLICKING ON THE "I AGREE" OR SIMILAR BUTTON, REGISTERING FOR AN ACCOUNT, OR ACCESSING OR USING THE SERVICES, YOU ARE INDICATING THAT YOU HAVE READ, UNDERSTAND AND AGREE TO BE BOUND BY THESE TERMS OF SERVICE, WHETHER OR NOT YOU HAVE REGISTERED WITH THE SITE. IF YOU DO NOT AGREE TO THESE TERMS OF SERVICE, THEN YOU HAVE NO RIGHT TO ACCESS OR USE THE SERVICES. These Terms of Service are effective as of the date you first click "I agree" (or similar button or checkbox) or use or access the Services, whichever is earlier. If you accept or agree to these Terms of Service on behalf of your employer or another legal entity, you represent and warrant that: (i) you have full legal authority to bind your employer or such entity to these Terms of Services; (ii) you have read and understand these Terms of Service; and (iii) you agree to these Terms of Service on behalf of the party that you represent. In such an event, "you" and "your" will refer and apply to your employer or such other legal entity.

Any personal data you submit to the us or which we collect about you is governed by our Privacy Policy ("**Privacy Policy**"), available at https://www.treditiq/privacy. You acknowledge that by using the Services, you have reviewed the Privacy Policy. The Privacy Policy is incorporated by reference into these Terms of Service and together form and are hereinafter referred to as this "**Agreement**."

PLEASE NOTE: THIS AGREEMENT GOVERNS HOW DISPUTES BETWEEN YOU AND Tredit IQ CAN BE RESOLVED. IT CONTAINS A BINDING AND FINAL ARBITRATION PROVISION AND CLASS ACTION WAIVER (SECTION 15). PLEASE READ CAREFULLY AS IT AFFECTS YOUR LEGAL RIGHTS, INCLUDING, IF APPLICABLE, YOUR RIGHT TO OPT OUT OF ARBITRATION.

#### 1. Our Services

We develop, maintain, and provide various risk management tools (the "Services") that help paying users of our Services ("Tenants") and their customers ("Customers") build and

manage their credit relationships. For the avoidance of doubt, a user of the Services may be categorized as both a Customer and a Tenant, as applicable.

Any Tenant's use of the Services is subject to a valid subscription, pursuant to the terms of the online registration page or a separate agreement or purchase order (each an "Purchase Order"), or subject to certain free evaluation terms that Tredit IQ may make available from time to time. We may make the Services or any part of it available to a Tenant on an evaluation basis until the earlier of: (i) the end of the applicable evaluation period pursuant to the Purchase Order; (ii) Tenant's purchase of a Services subscription; or (iii) any termination of the evaluation by us for any reason, or for no reason at all, by sending Tenant a termination notice with immediate effect.

## 2. Account, Password, Security, and Mobile Phone Use

You, and each individual affiliated with you that has been authorized to use the Services on your behalf, must register with Tredit IQ and create an account to use the Services (an "Account") and as part of that process you will be requested to provide certain information, including without limitation your name, full address, phone number, and email address. By using the Services, you agree to provide true, accurate, current, and complete information as prompted by the registration process and to maintain and promptly update the Account information to keep it accurate, current, and complete. You are the sole authorized user of your Account. You are responsible for maintaining the confidentiality of any log-in, password, and Account number provided by you or given to you by Tredit IQ for accessing the Services. As the Account Owner, you are solely responsible for complying with these Terms of Service and only you are entitled to all benefits accruing thereto. Your Account is not transferable to any other person or account. You must immediately notify us of any unauthorized use of your password or identification or any other breach or threatened breach of our security or the security of your Account.

#### 3. Billing and Payment

All prices and fees displayed on the Services are exclusive of applicable federal, provincial, state, local or other governmental sales, goods and services or other taxes, fees or charges now in force or enacted in the future ("**Taxes**"). Any applicable Taxes are based on the rates applicable to the billing address Tenant provides to us, and will be calculated at the time of a transaction is charged to your Account. Unless otherwise indicated, all prices, fees and other charges are in U.S. dollars, and all payments shall be in U.S. currency.

#### 4. User Generated Content

Tredit IQ optionally enables users to contribute content, such as credit approvals, notes and trade reference contributions to other businesses, which may be utilized by you and others to inform underwriting decisions or other business purposes. "**User Generated Content**" is defined as any content, information, and materials that may be textual, audio, or visual that you provide, submit, upload, publish, or make otherwise available to the Services and our users.

You agree that you are solely responsible for the User Generated Content sent or transmitted by you or displayed or uploaded by you in using the Services and for compliance with all laws applicable to the User Generated Content, including, but not limited to, any laws requiring you to obtain the consent of a third party to use the User Generated Content and to provide appropriate notices of third party rights. investigative, or unlawful purpose. You hereby warrant and represent that you will promptly disclose to Tredit IQ in writing any such motivation, status or interest, whether existing prior to registration or as arises during your use of the Services. 5 You may not access or use the Services in order to compete directly or indirectly with Tredit IQ, or for monitoring the Service's availability, performance, functionality, or for any other benchmarking or competitive purposes.

### 6. Termination and Suspension

Unless otherwise agreed to in writing between you and Tredit IQ (including via a Purchase Order), either party may terminate these Terms of Service for any or no cause, at any time. You agree that if the matter remains unresolved for 30 days after notification (via certified mail or personal delivery), such matter will be deemed a "Dispute" as defined below. Except for the right to seek injunctive or other equitable relief described under the "Binding Arbitration" section below, should you file any arbitration claims, or any administrative or legal actions without first having attempted to resolve the matter by mediation, then you agree that you will not be entitled to recover attorneys' fees, even if you may have been entitled to them otherwise.

Binding Arbitration. You and Tredit IQ agree that any dispute, claim or controversy arising out of or relating to this Agreement or to your use of the Services (collectively "Disputes") will be settled by binding arbitration, except that each party retains the right to seek injunctive or other equitable relief in a court of competent jurisdiction to prevent the actual or threatened infringement, misappropriation, or violation of a party's copyrights, trademarks, trade secrets, patents, or other intellectual property rights. The arbitrator will be either a retired judge or an attorney licensed to practice law in the state of Georgia and will be selected by the parties from the AAA's roster of arbitrators with relevant experience. If the parties are unable to agree upon an arbitrator within seven days of delivery of the

Demand for Arbitration, then the AAA will appoint the arbitrator in accordance with AAA Rules.

Arbitration Location and Procedure. Unless you and Tredit IQ agree otherwise, the seat of the arbitration shall be in Atlanta, Georgia. If your claim does not exceed USD\$10,000, then the arbitration will be conducted solely on the basis of documents you and Tredit IQ submit to the arbitrator, unless you request a hearing and the arbitrator then determines that a hearing is necessary. If your claim exceeds USD\$10,000, your right to a hearing will be determined by AAA Rules. Subject to AAA Rules, the arbitrator will have the discretion to direct a reasonable exchange of information by the parties, consistent with the expedited nature of the arbitration. Hearings may be conducted by telephone or video conference, if requested and agreed to by the parties.

Arbitrator's Decision and Governing Law. The arbitrator shall apply Georgia law consistent with the Federal Arbitration Act and applicable statutes of limitations, and shall honor claims of privilege recognized by law. The arbitrator will render an award within the timeframe specified in the AAA Rules. Judgment on the arbitration may be entered in any court having jurisdiction thereof. Any award of damages by an arbitrator must be consistent with the "Disclaimers and Limitations of Liability" section above. The arbitrator may award declaratory or injunctive relief in favor of the claimant only to the extent necessary to provide relief warranted by the claimant's individual claim.

**Fees**. Each party's responsibility to pay the arbitration filing, administrative and arbitrator fees will depend on the circumstances of the arbitration and are set forth in the AAA Rules.

#### 16. Governing Law

#### 18. General Provisions

The provisions of this Agreement are intended to be interpreted in a manner which makes them valid, legal, and enforceable. Except for the "Class Action Waiver" in Section 15, in the event any provision is found to be partially or wholly invalid, illegal or unenforceable: (i) such provision shall be modified or restructured to the extent and in the manner necessary to render it valid, legal, and enforceable or; (ii) if such provision cannot be so modified or restructured, it shall be excised from the Agreement without affecting the validity, legality or enforceability of any of the remaining provisions.
